

**DP CHRISTIAN SCHOOL**  
**PARENT AGREEMENT**

**PLEASE READ THE FOLLOWING AGREEMENT CAREFULLY. YOUR ENROLLMENT FOR YOUR STUDENT(S) INDICATES THAT YOU HAVE READ, UNDERSTAND, AND AGREE WITH THE POLICIES, MISSION, PURPOSE, AND PHILOSOPHY OF THE DP CHRISTIAN SCHOOL.**

1. I/We have investigated the policies, procedures, vision, purpose, philosophy, and statement of faith of the learning environment at DP Christian School (hereafter referred to as DPCS). I have read the parent/student handbook, agree with, and commit to cooperate and uphold all items as outlined in the document.
2. We will pay all tuition, registration/testing fees, and any other fees that may be incurred as established by the school.
  - a. We will pay all costs incurred by the school to collect fees should such actions become necessary.
  - b. We acknowledge that there will be a \$35 non-refundable late fee for any invoices not paid on time.
  - c. We will notify the school on time should unforeseen circumstances arise where tuition cannot be paid as agreed.
  - d. We have read and understood the financial obligation and payment schedule.
  - e. We further understand that delinquency in payment is grounds for student expulsion from school or delay in report cards to transferred schools.
  - f. We understand that if our student is expelled or we choose to unenroll, all non-consumable books are the property of DPCS and are non-refundable.
  - g. Tuition is also non-refundable for days used.
3. We are aware that DPCS is a Bible-centered, spirit-filled learning environment and support that instruction.
  - a. We understand that DP Christian School and DP City Church consider all teachers and staff to be ministers of the Gospel before they are deemed, academic teachers.
  - b. Therefore, we understand that staff and teachers have the freedom to speak the truth of Biblical standards in classroom instruction, discussion, and conversations.
4. As parents/guardians, we agree to support and continue our student(s) spiritual training at home.
  - a. We understand the obligation to be actively involved in the education of our children.
  - b. We agree to uphold and support the school's high academic standards by encouraging our child's study habits and ensuring that our child completes all homework and other assigned projects.
5. We will faithfully support the school through our prayers and positive attitudes. We will share any complaints only with the parties involved.
6. We understand that DPCS does not tolerate obscenity, profanity, defamation of God's Word, disrespect toward staff members, fellow students, or school policies by DPCS students. We commit to setting the same example when we are on campus.
7. We understand that if for any reason, our child does not respond favorably to the school, we will do everything in our power to cooperate with the school to help our child make the necessary adjustments. If these adjustments cannot be made, we agree to withdraw our child at the school's request to help them succeed in a different learning environment.
8. If any of the information in the student's admission application is found to be intentionally untrue, DPCS reserves the right not to enroll the student or to dismiss the student from school.
9. We agree to make every effort to have our students to school in time. Excessive tardiness and absences may result in suspension and possibly expulsion from DPCS.
10. We agree that if for any reason there is a conflict with the teaching method of our child's teacher or disagreement with the curriculum being taught, we will meet with the teacher and school administrator to discuss the issue and work with the school to resolve the problem to help our student achieve success.
11. If there is reason to believe that a student is in danger or they are a threat to another, the administration shall notify the police so that the student might receive appropriate outside treatment and assessment. If the student's parents or legal guardian cannot be reached, this step can be taken without their permission. Administration may disclose personally identifiable information from the student's records to the appropriate party.
12. We understand and agree that my child's continued enrollment and re-enrollment at DPCS depends on my parental support of the school, its staff, and its policies.
13. We do now agree and understand that DPCS and the DP City Church are not responsible and therefore not liable in any manner for lost, missing, stolen, or damaged personal property. No monies shall be paid to any student or parent claiming the loss or damage of such items.
14. We understand that our campus and DP City Church is a drug and alcohol-free zone. Any drugs or alcohol found on a student are grounds for immediate expulsion.
15. We have read and understood the non-discrimination policy outlined in the parent-student handbook.

16. We understand that every effort will be made to protect and safeguard all students. Therefore, we agree not to hold DPCS or DP City Church liable for any illness or mishap that may occur to our child. We will cooperate with the discipline policies as set forth by DPCS.
17. We will be communicative with the staff and teachers when we have a concern regarding our student(s) academics, grades, behavior, or other issues which may arise.

**We agree to the statements listed above. Failure of parents or children to comply with the above commitments will forfeit the student's privilege of attending DPCS.**

**By enrolling our student(s), we certify that we have and will provide information throughout the selection process, including on this registration application and in interviews; that is true, correct, and complete to the best of our knowledge. We certify that we have and will answer all questions to the best of our ability. We have not and will not withhold any information that would unfavorably affect our application to attend DP Christian School. We understand that information contained on our application will be verified by DPCS. We understand that misrepresentations or omissions may be cause for immediate rejection as a student at DPCS or the termination as a student at DPCS with no refund.**
