New Student Application & Enrollment Fee: \$150.00 (non-refundable)

Returning Student Enrollment Fee: \$100.00 (non-refundable)

Lower Elementary School (TK – Kindergarten)

Yearly Tuition: \$5,000.00

Book / School Fees: \$ 200.00

Elementary/Middle School (1st – 8th)

Yearly Tuition: \$5,100.00

Book / School Fees: \$ 300.00

High School (9th & up)

Yearly Tuition: \$5,700.00

Book / School Fees: *Included in tuition*

- Book / School Fees must be paid by October 1, 2025.
- Book / School Fees include technology, books, some class supplies, one school t-shirt
- Tuition not paid in full can be placed on a payment plan for a monthly loan fee of \$10.00. (*placed on tuition account*)
- All fees must be paid in full by June 1, 2026.

Lower Elementary (TK – K5)	\$416.66 + \$10 fee = \$426.66	\$500.00 + \$10 fee = \$510.00
Elementary / Middle School (1 st – 8 th)	\$425.00 + \$10 fee = \$435.00	\$510.00 + \$10 fee = \$520.00
High School (9 th & up)	\$475.00 + \$10 fee = \$485.00	\$570.00 + \$10 fee = \$580.00

- Tuition Payment Plan Options do not include Book/School Fees and Application/Enrollment Fee.
- These rates are valid through July 1, 2025. Students who enroll after July 1, 2025, are subject to alternate payment plans.
- Payment plans listed above are for payments beginning July 1, 2025, and ending June 1, 2026.

Co-Curricular Fees

- Participation in co-curricular activities may have additional fees to cover supplies, uniforms, coaching, chaperones, etc.
- Other fees include (but are not limited to) field trips, yearbooks, athletics, performing arts, school pictures, etc.

Withdrawal

The withdrawal policy includes parent withdrawal requests, student absences, and/or expulsions.

For withdrawals received during the following periods after enrollment has been paid: (enrollment fees & school fees are non-refundable)

- **February 1, 2025 – June 30, 2025** – No tuition responsibility when a student withdraws.
- **July 1, 2025 – August 1, 2025** – Responsible for 25% of the annual tuition obligation.
- **August 2, 2025 – September 2, 2025** – Responsible for 50% of the annual tuition obligation.
- **September 3, 2025, & thereafter** – Responsible for 100% of the annual tuition obligation. No refunds or credits will be issued.

Past Due Accounts

Families with past due accounts may not be able to participate in activities such as extended care, sports, field trips, etc., until the account has been brought current.

Additional Fees

Families can incur the following fees if any portion of the monthly payment is past due or if a payment is returned.
